

## Ad Hoc Pitt-Bradford Sustainability Plan Subcommittee of the Pitt-Bradford Sustainability Committee

To further Pitt-Bradford's efforts in advancing Pitt Sustainability Plan goals, the Pitt-Bradford Sustainability Committee is initiating an Ad Hoc Subcommittee to develop the first [Pitt-Bradford Sustainability Plan](#). Starting in July 2024, the Subcommittee is anticipated to serve through June 2025 or until the *Pitt-Bradford Sustainability Plan* is published and initiated.

This Ad Hoc [Pitt-Bradford Sustainability Plan](#) Subcommittee will lead the creation of a *Pitt-Bradford Sustainability Plan* aligned with and reflecting the [2018 Pitt Sustainability Plan's 68 goals, including](#) its forthcoming goal rejuvenations. This first *Pitt-Bradford Sustainability Plan* is anticipated to both share goals with the University-wide *Pitt Sustainability Plan* aligned with the original strategy specifically tailored to Pitt-Bradford's unique environment to inform future work. The 2018 *Pitt Sustainability Plan* was developed by the (now) Chancellor's Advisory Council on Sustainability, including representatives from the University of Pittsburgh's regional campuses.

**The primary charge of the Ad Hoc [Pitt-Bradford Sustainability Plan Subcommittee](#) is to develop and publish a [Pitt-Bradford Sustainability Plan that reflects existing University-wide sustainability goals and Pitt-Bradford's internal stakeholders' priorities, while setting discrete performance objectives. In achieving this goal, the Subcommittee will:](#)**

- 1) Include representation from a broad subsection of the University community
- 2) Include existing and forthcoming rejuvenated *Pitt Sustainability Plan* goals applicable to Pitt-Bradford.
- 3) Gather stakeholder input from Pitt-Bradford students, faculty, and staff via an institutional survey and targeted outreach and engagement.
- 4) Advance *Pitt-Bradford Sustainability Plan* through Pitt-Bradford's governance structure.
- 5) Work with University's Office of Sustainability to ensure the *Pitt-Bradford Sustainability Plan* aligns with University-wide goals and strategy, including support from the Chancellor's Advisory Council on Sustainability and University senior leadership.
- 6) Create a strategy for promoting the Plan through University and community engagement.

**Once the *Plan* is created, the Pitt-Bradford Sustainability Committee will be responsible for:**

- 1) Guiding the implementation, tracking, reporting, and achievement of the *Pitt-Bradford Sustainability Plan*. Reporting will occur through the Chancellor's Advisory Council on Sustainability and University's Office of Sustainability.
- 2) Celebrating accomplishments and performance.

### ***Proposed Committee Structure***

The University's Office of Sustainability will facilitate the Ad Hoc Subcommittee. Committee representation will include staff, faculty, and students, with specific representatives from the following departments at a minimum, as appointed by the Pitt-Bradford Sustainability Committee (and nominated by the departments / areas).
